**Communiqué of the Meeting of the SPLM Tripartite Committee on the Implementation of
Phase I of the Arusha SPLM Reunification Agreement**

Arusha, Tanzania

We, the delegates to the **SPLM Tripartite Committee** established under Article 41 of the Reunification Agreement, met in Arusha, Tanzania from February 12 – 16, 2015 under the auspices of Chama Cha Mapinduzi (CCM) and facilitated by former Vice Chairman of CCM, Dr. John Samuel Malecela, hereby issue this Communiqué:

The SPLM Groups welcome the coming into immediate effect of the Agreement on the SPLM Reunification signed on January 21, 2015 in accordance with Article 42.


The Tripartite Committee applauds the positive actions taken by the SPLM Groups since the signing of the Reunification Agreement, including: the endorsement by the Leadership Council of the SPLM/A (IO) on January 23, 2015; the approval of the Reunification Agreement by the SPLM National Liberation Council on January 26, 2015; and the endorsement by the SPLM Leaders (FDs) in their Press Statement of February 12, 2015.


The Tripartite Committee welcomes the inclusion of the African National Congress (ANC) into the Intra-SPLM Dialogue process as a Co-Guarantor with CCM.


The Tripartite Committee agreed on a Roadmap for the Implementation of the SPLM Reunification Agreement which entails Preparatory Measures for the anticipated arrival in Juba of SPLM/A (IO) and the SPLM Leaders (FDs). The Preparatory Measures include: Regional Consultations; Security Measures for the protection of members of the Tripartite Committee; revocation of the decision for dismissal of party cadres; formal ending of the status of exile imposed on FDs; Unfreezing of personal bank accounts and redress for consequential damage and losses.

The Tripartite Committee expresses its gratitude and appreciation to the sisterly Parties of CCM under the Chairmanship of Comrade Jakaya Mrisho Kikwete and the ANC under the Chairmanship of Comrade Jacob Gedleyihlekisa Zuma and the support of Crisis Management Initiative (CMI) and the solidarity of other sisterly Parties in the region.
